Notice Inviting Expression of Interest (EOI) for empanelment of Health Care Organizations (HCOs) (Hospital/ Diagnostic Centre/ Imaging Centre/ Dialysis Centre/ Blood Bank) located in the Maharashtra State for providing Super Specialty Services (Tertiary care only)

Regional Director, ESI Corporation, Regional Office, Maharashtra invites Expression of Interest (EOI) from Health Care Organizations (HCOs) (Hospital/ Diagnostic Centre/ Imaging Centre/ Dialysis Centre/ Blood bank) located in all districts of the Maharashtra State for empanelment for Two years for Super Specialty services and Blood Bank services (mentioned in clause no. 14.7 and 14.8 of Referral policy) for ESI beneficiaries / Staff / Pensioners of Maharashtra State on cashless basis.

The application window will open on a half-yearly basis during the financial year 2025–26. Interested HCOs may submit their application within the stipulated periods, as per the schedule outlined below:

01/12/2025 – 15/12/2025

The applicants shall have to submit their application as per Annexure A1, A2, A3 and A4 whichever is applicable duly filled along with required documents mentioned in referral policy.

A2 - For Diagnostic Laboratories/ Imaging Centers (Page no. 104 to 109)

A3 - (Exclusive Dialysis Centers/Eye Centre (for vitreo-retinal Procedures) (Page no. 110 to 115)

A4 - For Blood Bank Services (Page no. 116 to 121)

This interested and eligible Health Care Organizations (HCOs) having necessary expertise and experience shall have to submit their Application form along with Earnest Money Deposit (EMD). The EMD to be submitted by the HCOs is detailed below:-

Type of Institution	EMD
1. Multi-Specialty Hospital	Rs. 2,00,000/- (Rs Two Lakhs only)
2. Stand Alone / Diagnostic /Imaging Centre /Eye/ Dialysis Centre	Rs. 1,00,000/- (Rs One Lakh only)
3. Blood Bank Centre	Rs. 1,00,000/- (Rs One Lakh only)

HCO has to pay the above said amount in the form of Demand Draft only, in favour of “ESI FUND ACCOUNT NO. 1” payable at Mumbai. The application along with all requisite documents and the Demand Draft (as mentioned above) to be submitted in physical form in a closed envelope.
